P/01481/16 Cracknells, Halletts Shute, Norton: LBC for proposed single storey extension (revised scheme)

P/01542/16 Greystone, Greystones Lane, Freshwater: Demolition of conservatory; proposed single storey extensions on side elevations; alterations to include dormer window on front elevation and balconies at 1st floor level on side elevations

P/01516/16 81 School Green Road, Freshwater: Single storey rear extension, rear canopy, alterations to existing side extension and additional first floor window to rear elevation
